## 1. PLACE AND DATE

The PERUMIN 37 Mining Convention will take place in the city of Arequipa from September 22 to 26, 2025, at the Centro de Convenciones Cerro Juli, located at Campo ferial Cerro Juli s/n, José Luis Bustamante y Rivero, Province and Department of Arequipa.

## 2. PARTICIPANTS

- Those interested in participating should access the website [www.perumin.com](http://www.perumin.com) and register their information online.
- Participants must fill out all the information requested in the registration form; otherwise, they will not be allowed to continue with the online registration process.
- Participants must pay the total amount of the registration fee and/or requested service before September 2025; otherwise, they will not have access to PERUMIN 37.
- Any IIMP member who wishes to register for PERUMIN at the applicable fee must have been a member for three months before the event's opening and must be in good standing (for natural persons only).
- A one-time participant change is allowed at no additional cost. As of the second change, a 20% penalty on the registration fee will be charged. All changes require prior coordination and authorization by the IIMP representative in charge of registrations. Changes will not be allowed once the material has been received.
- The student registration fee applies to undergraduate students in their last semester who are ranked among the top 1/5th in their class. They must submit a certificate from their university accrediting them as students. Limited availability.
- The professor registration fee applies to full-time professors or professors with a full workload (not valid for post-graduate professors). They must submit a letter from the university where they teach.

## 3. BADGES

- The badges and/or QRs are the participant IDs during the event.
- If a badge gets lost or stolen, its replacement will have a cost of PEN100.00.
- Badges and/or QRs are personal and non-transferable. Participants must show them at the entrance or upon request by a representative of PERUMIN while at the venue.
- Badges must be picked up IN PERSON; however, they can also be picked up by the company's representative, who must present a letter of authorization for badge pickup from the company's legal representative. The letter must include the name and ID of the person picking up the badges, as well as the participants' information, including names and IDs.

## 4. WITHDRAWAL

- Participants who withdraw will be charged a 10% penalty on the registration fee until Friday, August 22, 2025.
- As of August 23, 2025, participants will receive no refund at all for withdrawals. If the case arises, a one-time change of the badge holder's name is suggested.

## 5. PARTICIPANT BENEFITS

Those participating in the PERUMIN 37 Mining Convention will enjoy the following benefits:

- Access to the Mining Summit and the TIS Forum conferences (Conventioneer Category) with simultaneous interpretation service (English - Spanish).
- Access to the commercial conferences (without simultaneous interpretation).
- Access to the recordings of the conferences.
- Access to networking through the app.
- Digital certificate of participation upon request
- Access to presentations in PDF format of authorized conferences.
- Access to EXTEMIN 2025.
- Participation in the social activities included in the program.
- Coffee breaks.
- Limited hotel booking arranged by the PERUMIN 37 Mining Convention's organizers and paid by the participant. In case of unavailability, hotel reservations will be made by the participant.
- Transportation from the official hotel to the venue and vice versa, as well as transportation to the social activities for those participants who book their accommodation in the official hotel.

- Badge and material pickup  
Before and during the event (Arequipa)  
From Monday, September 1 to Friday, September 26, at a venue to be announced.  
  
From 08:00 to 18:00 (subject to variation)
- QRs will be sent as of September 1 to all registered participants.  
QRs will only be sent to those who have paid 100% of their registration fee and/or have authorized

## 7. INVOICING

- Adherent IIMP members who wish to participate have up to fifteen (15) calendar days of credit to pay their registration fee once they have received their invoice. It is worth noting that the invoice must be paid for the participant to receive his/her badge and materials. Participants must provide all the documentation needed to issue the corresponding invoice, such as, but not limited to, the Purchase Order, if applicable.
- Any person and/or company that is not an IIMP member must pay their registration fee within 48 hours at the latest; otherwise, their registration will be invalidated, or their spot will be made available to the public. To confirm payment, you must submit your proof of payment or voucher to [inscripciones@iimp.org.pe](mailto:inscripciones@iimp.org.pe)
- If you need an invoice, you MUST provide the company's name and address.
- For national companies, according to SUNAT regulations, the participant must deposit 12% of the total amount of the invoice (advance VAT withholding) to the account of the Peruvian Institute of Mining Engineers at Banco de la Nación (advance VAT withholding account PEN No. 00000372668). If the invoice is paid in full, the IIMP itself will withhold the amount.
- Once the type of payment voucher has been specified in the registration form, such document may not be changed.

## 8. PAYMENT METHODS

### 8.1.- Online Payment

- All cards accepted: Visa, Mastercard, American Express, Diners, Saga, Ripley, and cards from all national and international banking institutions, so that you can make a secure online payment.
  - Payment with Credit and/or Debit Card
- The participant can make his/her payment through our PERUMIN 37 web page and/or our payment link. Registration staff will provide further information. To request information, the Participant must send an e-mail to: [inscripciones@iimp.org.pe](mailto:inscripciones@iimp.org.pe)

### 8.2.- Bank Deposit (against submission of invoice)

- Payment can be made via bank deposit to the accounts of the IIMP as follows:
  - 1. Go to: "Pago de Servicios"
  - 2. Choose: Inst. De Ingenieros De Minas Del Perú
  - 3. Select "Perumin" and choose the currency
  - 4. Enter the Service Code (this could be the RUC number, the company name, the invoice /receipt number, or the participant's ID number)

It is very important to provide complete information when making the payment to facilitate payment identification.

The participant will request the prior submission of the invoice. The order will be confirmed in writing via e-mail: [inscripciones@iimp.org.pe](mailto:inscripciones@iimp.org.pe)

### 8.3.- Wire Transfer

- The customer will be able to see the online wire transfer format with the total amount to be paid. He/She must then send a copy of the wire payment confirmation to [inscripciones@iimp.org.pe](mailto:inscripciones@iimp.org.pe), indicating the amount and the participant's and/or company's name(s).
- If registration is made during the event, the participant must show the original payment voucher to validate his/her registration.

- Only the amount deposited into the accounts of the IIMP will be considered. Bank charges or wire transfer fees will not be considered. International transfer fees imposed by your sending bank will be paid by the participant and/or the company.
- The IIMP is not liable for unidentified deposits.

## 9. LIABILITY OF THE IIMP:

### Acts of God or Force Majeure

- The IIMP is not liable for non-compliance in the event of acts of God or force majeure. For these purposes, acts of God or force majeure is understood as a cause not attributable to the IIMP, such as an extraordinary, unforeseeable, irresistible event that prevents the IIMP from complying with its obligations regarding the organization and development of the PERUMIN 37 Mining Convention and results in partial, late, or defective compliance.
- Such events include, but are not limited to, fires, tremors, earthquakes, tsunamis, landslides, avalanches, floods, torrential rains, storms, explosions, military conflicts or external or internal wars, pandemics, epidemics, civil unrest, blockades, acts of terrorism and sabotage, uncontrollable delays in transportation, strikes, as well as any other similar or different cause, including any events beyond the reasonable control of the IIMP and that could have not been anticipated or prevented, and damages and losses caused to equipment, tools, and material.

### Event Postponement

- The IIMP reserves the right to unilaterally modify the dates of the event, in which case the participant will not be entitled to any kind of compensation whatsoever.

## 10. LIABILITY OF THE PARTICIPANT

- If an invalid badge and/or a badge that does not belong to a participant is identified, it will be confiscated, and the participant will be denied access, without prejudice to the right of the IIMP to file the respective complaint before the competent police authorities within twenty-four (24) hours.
- If the participant shows signs of intoxication with alcohol or other substances, he/she will be immediately requested to leave the venue, and his/her badge will be confiscated permanently.
- In none of the aforementioned cases will the participant be entitled to a refund of the paid registration fee.

## 11. ACCESS CONTROL

- Participants must pay their registration fee before entering the venue; otherwise, they will be denied access.
- Participants must use their QR and/or badge to identify themselves.
- The categories EXTEMIN one-day pass, EXTEMIN additional pass, and the companies' guests will only be allowed access to the fair.
- All press must be authorized by the communications area. Press authorization must be previously validated by the responsible area for its corresponding accreditation.
